### Information Collection and Use

Information, including personal information, is collected for site administration and to support, improve and obtain feedback on Eurologix Security Group services and to prevent and detect breaches of Eurologix Security Group network security, the law or contracts.

Technical data is collected throughout the site. Optional contact data is collected from specific forms which each state the purpose(s) for which information is being obtained. These include opportunities to register with Eurologix Security Group in order to receive our newsletter and announcements by email from us; to apply for employment with us; to submit a form or e-mail requesting information, to request spare parts or to complete a questionnaire.

The information you supply to us is controlled by the privacy policy in effect at the time you submit it.

## Site operation and cookie

We use cookies to help us control the web site. A cookie is a piece of data stored on the user's computer linking information about that user. It allows web applications to respond to you as a distinct individual.

For the session ID cookie, once users close the browser, the cookie simply terminates. A persistent cookie is a small text file stored on the user's hard drive for an extended period of time. Persistent cookies can be removed by following Internet browser help file directions.

How does Eurologix Security Group manage and track online advertising and site usage?

We use third-party advertising companies to serve ads when you visit our web site. #### Registration opportunities

When customers provide us contact information (user participation is voluntary and users can opt-out by e-mailing Unsubscribe to [info@eurologix.eu](mailto:info@eurologix.eu)) we use the information to contact the user to deliver sales and product information that will be useful to them.

We will use the information we collect from the web site for a direct mailing, such as a Newsletter, only if you expressly give us prior permission. If you decide you no longer want to receive such mailings, you can remove yourself by sending an e-mail to the address provided at the time.
